**ORDER**

November 17, 2023

The Complainant alleged a superior court judge failed to hold a conference call within sixty days of taking the case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Michael B. Brown did not participate in the consideration of this matter.

on [redacted] after another Judge violated my due process rights when she delayed the third scheduled jury trial on hearsay not prior request to the court after waiting [redacted] she ignored my objection and the lawyer i hired but was not with hm objected due to public safety statutes and fire hydrant easement being used to park cars when the easement does not allow paving next to fire hydrant. the documents were concealed by all parties for [redacted] years. wasting my social security income when i pay hoa dues to protect my deed instead they are protecting felons who have abused ,my grown son due severe jealousy never seen people this insecure who were odd since they moved in . threateing my son he is going to kill us pver graffiti he told his son to do to my property in [redacted] this case is felony malice and cannot go to binding arbitarpr due to public safety statutes/ that a jury would vote on but we never got our rights to jury trial bias and prejudice in this case is clearly federal crime/ color of law violations . judge was assigned after i presented physical evidence tp clerk of [redacted] court of lawyer calling and arranging arbitration without following rules 72-79. 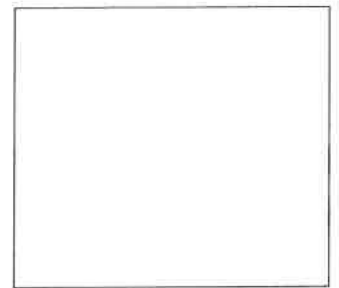

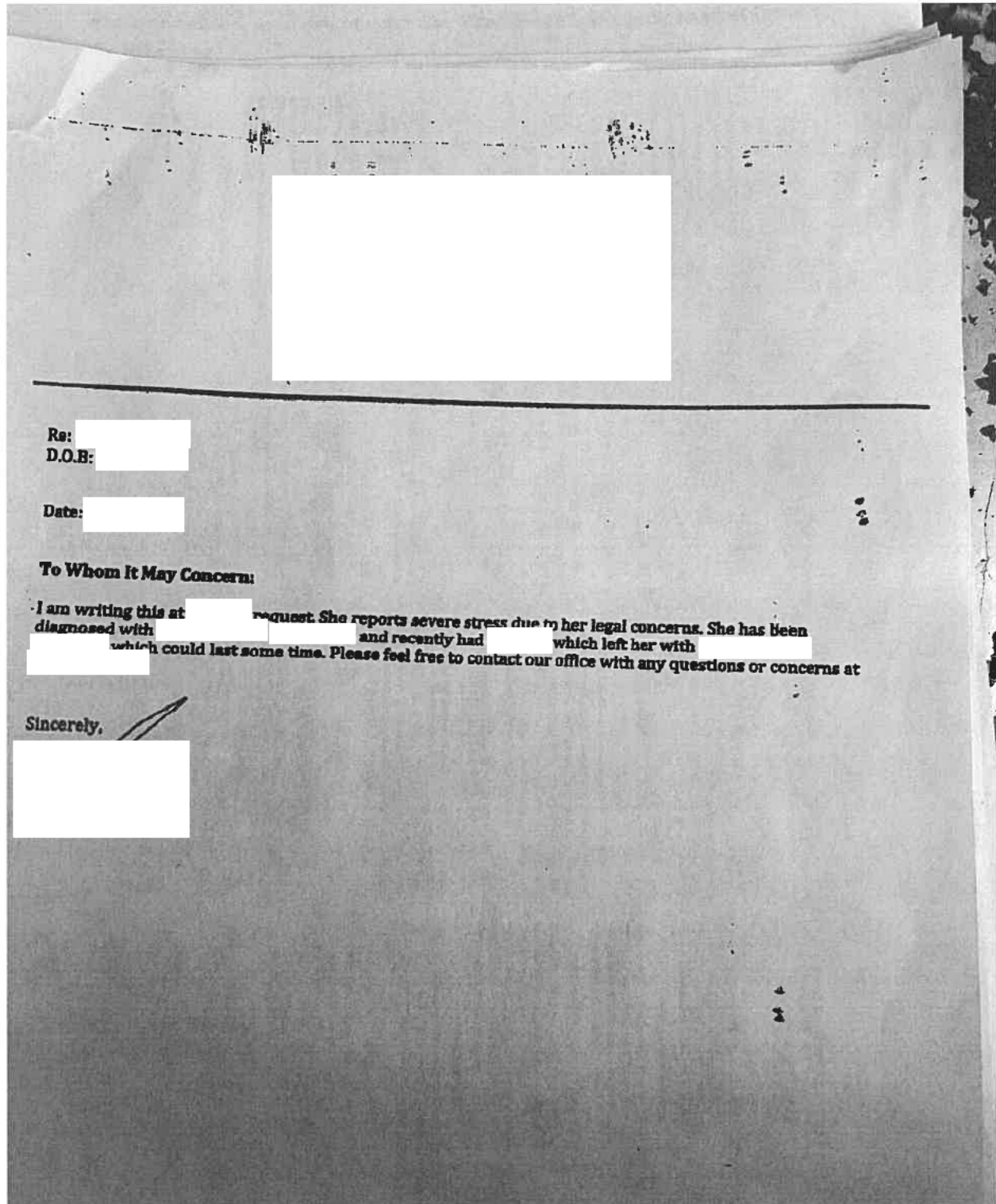
