**ORDER**

January 12, 2024

The Complainant alleged a superior court judge had a conflict of interest in hearing his case, refused to provide her oath of office, and manipulated the court docket in a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Joseph C. Kreamer did not participate in the consideration of this matter.

I believe they spoke before proceedings and articulated a plan to attempt to place me in contempt of court again to aviod me challenging jurisdiction, or asking for her oath, stating I was put in to contempt because I hadn't gotten along with \_\_\_\_\_ even after I explained he isn't listening to me and has been VERY AGGRESSIVE towards me and I don't feel safe with him representing me. My father witnessed her allow him to lie on the record and witnessed her deny me a fair trial by stating on the record she will not afford me a new attorney after I conveyed my concerns and replied, I must represent my self if I want any other counsel and even then said she would have to examine me for mental stability in which I feel she would send me to get an mental evaluation, just to avoid me asking her questions she doesn't like, like who is the injured party. She is showing ego driven rationalizations, and failed to be a neutral party or a fair judge. I plan on filing a civil rights complaint/suit this week with the AG office because she is in direct violation of my civil rights. I also believe she is manipulating the docket. She stated on the record she had not received any notices I filed with the clerk. She stated on the record I wasn't allowed to file anything unless I was Pro Se, But the docket is showing she is recieving the documents and not recongizing them or filing them onto the docket until she feel fit. Then a waiver was filed as soon as she saw the Demand for Oath of Office but she allowed filing up until then, which shows signs of \_\_\_\_\_. I have pictures taken of the online docket to show there is clear manipulation to favor the courts. I believe there is corruption in the courts and she is involved ailing in some sort of illegal scheme. I will be paying a private investigator and filing for a investigation with appropriate authorities because her behavior is unjust. She I believe she is unfit to judge. As I stated in the Demand for Oath of Office US COURTS - Code of Conduct for United States Judges - Canon 2A, states, "An appearance of impropriety occurs when reasonable minds, with knowledge of all the relevant circumstances disclosed by a reasonable inquiry, would conclude that the judge's honesty, integrity, impartiality, temperament, or fitness to serve as a judge is impaired." I demand remedy to a fair hearing from a judge that has zero conflict of interest in this, and/or any further pceedings relating to this case.
