# ORDER

### October 13, 2023

The Complainant alleged improper legal rulings by a superior court judge hearing a dependency case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Colleen E. Concannon did not participate in the consideration of this matter.

At this point I asked him has someone hurt him he said yes mommy did it I ask him I immediately was furious and wanted to talk to someone about where hurt him he said was where she was and if she was also being harmed . My child would not lie to me and he is who and I have a amazing bond he is my 1st son I am broken hearing him say that and when verv smart and was kicked out the visit as if I was wrong for asking I voiced it to the case aide I had my visit about my children who are now with total strangers. I spoke up loudly and clearly from the word of God which is truth and was told I had a minute hearing by my lawyer which gave me hope to be able to speak and which that time I was muted almost the I had a hearing with Judge to the Judge so on mentioned my concerns I unmuted myself to entire hearing was not given a chance to speak when said what he said and also the placement allowed to go out of state to confirm it was true weekend which is a holiday I do not celebrate in any shape or fashion any over the told me no even after she heard the how when I asked if I would have a chance to speak Judge words human trafficking she then hung up in my face on the record leaving me to suffer wondering if my children are safe .
