ORDER

The Complainant alleged a justice of the peace engaged in stalking and other improper behavior.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Michael J. Brown did not participate in the consideration of this matter.

I luckily discovered this by accident online while checking on my filed law suits against both neighbors, and I beat it down to the court house and was able to quash the arrest warrant just issued, and reschedule the hearing too. The court personel said that they had just received the tranfered case from the _____ Court and that it was not fair to me as I had received no notice of the hearing I missed just hours ear *lier*. I believe that the *arrest* Court set me up for an arrest for missing the hearing date. Please note: I have emails showing my efforts trying to ascertain a new hearing date for tickets with Prosecutors Office who never responded.

Second Complaint:
