ORDER

The Complainant alleged delayed and improper legal rulings by a superior court judge hearing a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Joseph C. Kreamer did not participate in the consideration of this matter.

I filed multiple documents into the clerks office starting way back in . i didnt get any response to any of my filings for over a month until i decieced to make my filings public by recording them at the county recorders office my self. they told me the clerk hasnt been forwarding any of my documents at all and i have no record numbers for any of the files on my case. so i called around to see what was going on and why its been over a month since ive filed and ive gotten no response from the judge and no minute entries were put in for over a month. i took screenshots of the docket and of the minute entry. the day after i filed a bond with the county records office, that had already been filed with the clerk, the judge finailiy made a minute entry on after no responses were made to ANY of my filing for over a month. Since whatever i filed stipulated default if no response was given in days, judgement would be given in my favor this case should be over. but instead the courts cheated and made the most recent minute look as though it was posted over a month ago. the minute entry dated wasnt posted on to the docket until yesterday the ruling was over different filings, a demand for the bill of particulars which i requested so i can understand the rules and setting/venue and other vital information so i could proceed defense properly but it was not only denied it was denied conveniently in the states favor. also i alledged a conflict of interest. clearly all parties work for the state and the and both judges i had both shown favor towards the state. i was also denied but the information given had case law and information quoted out of arizona ag handbook and rules and conduct for state judges and still it was conveniently denied a month after i filed it. Due process grants me the right to a fair proceeding and im not being afforded that. the government must give fair notice on any action that can affect my life, liberity, or property. Im being rushed into judgement and the court is attacking me with its corrupt state paid judges. this is a conspiracy against the people. any logical person would agree. Judge told me I had no due process rights afforded on . I brought that to Judge attention, and my demand dismiss for conflictive interest, which he completely disregarded, which is another violation of my due process rights. They have been trying to silence me and rush me into judgment. There is no neutral magistrate, and I have not been afforded a fair proceeding I feel completely attacked by the state judges. None of them are making fair or just decisions thus far. I'm forced to contact the in the for now for an investigation on a conspiracy against human rights in the and the County Court I believe this is a criminal syndicate.g
