On April 12, 1999, the Court approved a petition for amendment to the Rules of the Supreme Court concerning the expenses of conducting the examinations and the character and fitness investigations for applicants for admission to the practice of law in the State of Arizona. In order to meet present expenses and adjust fees from time to time as may be necessary, the rules were modified to remove all references to specific amounts of fees and provide that the Supreme Court set fees by administrative order.

Further, on April 12, 1999, the Court approved a specific schedule of fees and on April 14, 1999, these fees were adopted by Administrative Order No. 99-24.

On November 28, 2000, by Administrative Order No. 2000-88, the Court approved the request of the Supreme Court Committee on Examinations to offer a pilot program giving applicants the option of utilizing computer technology to take the February 2001 examination for admission. Applicants were required to pay a fee of \$125.00 for this option, in addition to any other approved fees for the examination.

The Committee on Examinations reports the pilot program was successful and recommends laptop testing be offered for the July 2001 examination, again on a pilot program basis, limited to 100 examinees. The Committee also requests the authority to expand the availability of offering computer technology for examinations subsequent to the July 2001 examination.

Now, therefore, pursuant to Rules of the Supreme Court 33(f)(3)(a), 34(a)(b)(4)(5)(d), 35(d)(e) and 37(d) and Article VI, Section 3, of the Arizona Constitution,

IT IS ORDERED that at the discretion of Committee on Examinations and subject to budgetary decisions of the Administrative Director of the Courts, the Committee may offer applicants the option of utilizing computer technology to take the July 2001 examination, on a pilot program basis limited to 100 examinees.

IT IS FURTHER ORDERED that the Supreme Court Committee on Examinations may, in its discretion, offer applicants the option of utilizing computer technology to take examinations subsequent to July 2001. This discretion shall be subject to budgetary decisions of the Administrative Director of the Courts and availability of the necessary technology, resources and infrastructure.

IT IS FURTHER ORDERED that the Schedule of Fees in "Attachment A," is hereby adopted and effective as of the date of the filing of this Order replacing the fees previously set by Administrative Order No. 99-24.
