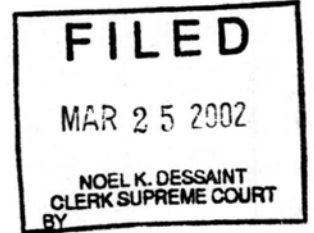

#### Certification Fee Schedule

Pursuant to A.R.S. §32-4008(A), the Arizona Supreme Court shall set and collect fees necessary to carry out the provisions of Title 32, Chapter 40, Arizona Revised Statutes pertaining to the certification of court reporters.

| 4. Reregistration<br><i>(For any applicant who registers for an examination date and fails to appear at the designated site on the scheduled date and time.)</i>    | \$ 25.00 |
