A.R.S. § 25-323.02, Laws 2002, Chapter 332, created the Domestic Relations Committee, previously the Domestic Relations Reform Study Subcommittee, for the purpose of preparing a statewide plan for an integrated family court with comprehensive subject matter jurisdiction over all matters involving the family and revising and reforming the State’s Domestic Relations Laws, Rules and Procedures. The Chief Justice is responsible for appointing six members of the total membership of 27 to the Domestic Relations Committee, consisting of two active or retired judges or commissioners or both from the domestic relations department of the Superior Court (one Rural and one Urban), a Clerk of the Superior Court, a representative of a conciliation court, an administrative officer of the Supreme Court, and a member of the Family Law Section of the State Bar of Arizona. Members serve at the will of the Chief Justice.

The Honorable Alma Jennings Haught, Clerk of the Superior Court in Pinal County, the Honorable Karen Adam, Domestic Relations Commissioner of the Superior Court in Pima County, Sidney Buckman, Representative of the Conciliation Court in Flagstaff, and Janet Scheiderer, Director of the Court Services Division of the Supreme Court, formerly members of the Domestic Relations Reform Study Subcommittee, desire to be reappointed to the Domestic Relations Committee.

The Chief Justice has chosen the Honorable Dale Nielson, of the Navajo County Superior Court domestic relations bench, to serve as the Rural Domestic Relations Judge/Commissioner, and Steven D. Wolfson, Chair of the Family Law Section of the State Bar of Arizona, to serve as the Family Law Section member. Therefore, after due consideration,
