On April 12, 1999, the Supreme Court approved a petition for amendment of the Rules of the Supreme Court to remove all references to specific amounts of fees and provide that the Supreme Court set fees by Administrative Order. The petition and subsequent Administrative Order No. 99-24 did not increase the fees.

On November 28, 2000, by Administrative Order No. 2000-88, the Court authorized a pilot project for the Committee on Examinations to allow applicants for the bar examination to utilize laptop computers when taking the examination and established a fee for this service. On May 30, 2001, by Administrative Order No. 2001-59, the Court authorized the ongoing use of laptop computers for the bar examination. Administrative Order No. 2001-59 also adopted the laptop fee established by Administrative Order No. 2000-88 and replaced the schedule of fees established by Administrative Order No. 99-24.

A recent review of the expenses for the administration of the bar examination, character and fitness investigation, and subsequent admission procedures indicate significant operating expense increases, and fees must be adjusted to ensure this function of the Court remains self supported. This review also determined the need to adjust the filing deadlines. In order to adjust these deadlines from time to time as may be necessary, the Court has approved amendments to Rule 34 to remove all references to the filing deadlines and provide that the Supreme Court set these deadlines by administrative order.

Now, therefore, pursuant to Rules 33 through 37 of the Arizona Rules of the Supreme Court, as amended, and Article VI, Section 3, of the Arizona Constitution,

IT IS ORDERED that the Schedule of Fees and Filing Deadlines in "Attachment A" is hereby adopted and effective as of August 1, 2004, replacing Administrative Order No. 2000-88 and replacing the schedule of fees established by Administrative Order No. 2001-59. All other provisions of Administrative Order No. 2001-59 shall remain in effect.
