APPOINTMENT OF MEMBERS TO THE FIDUCIARY BOARD Administrative Order No. 2006 - 111

On September 6, 2006 the Court issued Administrative Orders No. 2006-70 and No. 2006-71, adopting amendments to the Arizona Code of Judicial Administration §§ 7-201 and 7-202. These amendments authorized the establishment of the Fiduciary Board, effective January 1, 2007. Pursuant to § 7-201(D), the Chief Justice is responsible for appointment of members to the Fiduciary Board and shall initially appoint members to staggered terms of one, two and three years, to provide for continuity on the Board. Further, § 7-201(D) specifies the Chief Justice will select the chair of the Board from among the appointed members, to serve a term as chair for a period not to exceed three years. Administrative Order No. 2006-71 authorized the Chief Justice to make the appointment of the Board members prior to January 1, 2007 to provide for training of the members before the January 1, 2007 effective date of their service on the Board. Now therefore, after due consideration,
