In accordance with Administrative Order No. 90-13, the Chief Justice appoints advisory committees of the Arizona Judicial Council to assist the Council in carrying out its responsibilities; therefore,

IT IS ORDERED that an advisory committee on child support is established as a committee of the Arizona Judicial Council and shall be known as the "Advisory Committee on Child Support." This committee is created to: a) assist the Arizona Judicial Council and the Arizona Supreme Court by reviewing the recommendations of the Domestic Relations Division of the Administrative Office of the Courts for a new child support schedule and self-support level for working parents paying child support; and b) recommend to the Domestic Relations Division other studies of, or improvements to, the Arizona Child Support Guidelines, as the committee determines. These responsibilities shall be accomplished by February 28, 1996.

IT IS FURTHER ORDERED, Commissioner William David Anderson is appointed as Chair of the Advisory Committee on Child Support, and, as Chair, he is authorized to appoint subcommittees to assist the committee in carrying out its responsibilities.

IT IS FURTHER ORDERED the individuals named on the attached list are appointed as members of the Advisory Committee on Child Support and will serve until June 30, 1996.
