Call to Order

The meeting was called to order by Sandra Markham at 10:15 a.m.

Rhonda Simmons welcomed and introduced the new members of the Board Judge Lawrence Winthrop, Patricia Seguin, and Kathleen Montalvo.

Recommendations and Board Action

Applicants for Initial Certification

Applicants for Temporary Extensions

(During Executive Session, the Board reviewed the confidential records of the reporters who hold a current temporary certification)

A **motion** was made by William E. Druke and seconded by Judge Lawrence Winthrop to grant court reporters #10 and #11, as identified in Executive Session, an extension of their Temporary Certification through December 31,

2005 and to require that each reporter submit bimonthly status reports. Motion passed. **BR-05-14**.

A **motion** was nade by Judge Lawrence Winthrop and seconded by Jennifer Stadler to grant court reporters #1, #2, #4, #5, #6, #7 and #9, as identified in Executive Session, an extension of temporary certification through August 15, 2005; that each reporter be sent a detailed letter indicating what documentation was omitted in their request, and to require each court reporter submit bimonthly status reports. Motion passed. James Bouley recused himself from issues pertaining to Court Reporters #1, #3 and #5. **BR-05-015**.

A **motion** was made by Judge Lawrence Winthrop and seconded by Patricia Seguin, to grant court reporter #8, as identified in Executive Session, an extension of temporary certification through April 15, 2005; that this reporter be sent a detailed letter indicating what documentation was omitted in their request, and to require this reporter to submit bimonthly status reports. Motion passed. **BR-05-016**.

A **motion** was made by William E. Druke and seconded by Judge Lawrence Winthrop to grant court reporter #3, as identified in Executive Session, an extension of temporary certification through June 10, 2005, that this reporter be sent a detailed letter indicating what documentation was omitted in their request and to require this reporter to submit bimonthly status reports. .Motion passed. **BR-05-017**.

Rhonda Simmons stated Janice Fuller is requesting she be granted continuing education credits for presenting the "Total Eclipse Enhancements" seminar on February 12, 2005.

The seminar will last 3 hours. Rhonda Simmons stated according to the Code, court reporters may be credit for the full amount of the class presented plus an additional two credits for each hour of presentation time for preparation.

A **motion** was made by Jennifer Stadler and seconded by Patricia Seguin grant nine (9) hours of continuing education credit to Janice Fuller for presenting the "Total Eclipse Enhancements" Seminar on February 12, 2005 based on the determination that this class is directly related to court reporting. Motion passed. **BCCR-05-020**

Topics for Discussion

Senate Bill 1311

Rhonda Simmons informed the Board that Senate Bill 1311 passed unanimously by the Senate Government Committee. SB 1311 was amended by strike all provisions and a temporary certification provision was included for voice writers. If passed, the Board will have to discuss new rules, and validate the existing examination or develop and validate a new examination. NCRA does not allow voice writers to take the RPR right now, but are willing to entertain a request. Revisions to SB 1311 are being heard in Senate Judicial Committee this date.

Transcript Format

Rhonda Simmons informed the Board that the Transcript Format Workgroup was developing transcript format guidelines that the Board may wish to review and include portion in the Transcript Format Guidelines for court reporters. The Board discussed the issue.

Graduate Court Reporter Program

This presentation was postponed to a future Board meeting.

Program Update

Keeping the Record Committee

Rhonda Simmons provided an update to the Board on the KTR committee. Rhonda Simmons stated the Rules Workgroup met last Friday. It is beaning towards an RFP for contract registration for transcriptionists. Currently the proposed RFP is in draft form and will be presented to the full committee at the following meeting. The Standards Workgroup is working on transcript format standards. The Standards Workgroup informed the KTR Committee that they had decided it would be best not to change Rule 30B and to preserve the existing language.

Complaints

Rhonda Simmons reported there were no complaints prepared for discussion at this time.

Rhonda Simmons stated as of September 2004, there were 18 open complaints, 8 of which were backlogged (open for more than 22 months). In September 2004, two complaints were closed and one was received. In October one complaint was closed. In November one complaint was received. In December, seven were closed, 5 of which were considered backlogged, and 6 were received. In January one was received, and in February 3 were received. Rhonda Simmons informed the Board that as of the date of this meeting there are 20 open complaints, 3 of which are considered backlogged by the 22 month standard.

Rhonda Simmons also updated the Board on the current court reporter status. Rhonda Simmons stated there are 501 court reporters: 11 with Temporary Certification, 32 with Provisional Standard Certification and 458 with Standard Certification.

Adjournment

A **motion** was made by Patricia Seguin and seconded by William Druke to adjourn. Motion passed. **BCCR-05-021**
