CALL TO ORDER

The regular session was called to order by Chair Sandra Markham at 10:02 a.m.

Motion was made by Judge Winthrop to adopt the proposed schedule for 2007. Jennifer Stadler seconded the motion. Motion carried. **BCCR-06-149.**

2-D: New Board appointments.

Newly-appointed members to the Board of Certified Reporters are Terri Faust, Official Court Reporter, and Allan Sonntag, Freelance Reporter, to be effective January 1, 2007. They will fill the seats vacated by Jennifer Stadler and James Bouley whose terms expire January 1, 2007.

Judge Kearney stated she will be resigning her position on the Board to be effective after the January 8th telephonic Board meeting. Judge Druke has officially resigned effective immediately.

2-E: Additional Board Meeting in December.

Rhonda Simmons inquired if the Board wanted an additional meeting in December to discuss any late renewals and results of the RPR for provisional certificate holder renewals.

After discussion, Board agreed a December meeting would be advantageous and established December 28th as a telephonic Board meeting, 12:00 p.m. – 1:00 p.m.

2-F: Update on Certified Reporter Examination Revisions.

Rhonda Simmons updated the Board on the revisions to the Arizona Written Examination. They have held one focus group and will meet again on January 5th and January 8th and should have a new examination in place by the end of January. The new examination will reflect the most current changes to the applicable Arizona Code of Judicial Information.

Motion by Judge Winthrop and seconded by Jennifer Stadler to go into Executive Session at 10:40 a.m. Motion carried. **BCCR-06-150.**

3) CERTIFICATION AND ELIGIBILITY

3-A: Discussion and possible action regarding the Hearing Officer's Report and Recommendation with respect to Lydia Elias and the Board's response thereto.

Rhonda Simmons requested the Board defer action on the Hearing Officer's report waiting until the January 8th telephonic Board meeting, on the advice of legal counsel.

Ms. Simmons also read a letter from Ms. Elias sent to the Certified Reporter Program, received November 30, 2006, requesting the Board grant a continuation of her certification status until the first full board meeting in 2007. She stated she prepared for the RPR test and took the exam on November 4, 2006, but the results will not be posted and mailed until the week of December 18th.

Motion made by Jean Lea and seconded by Judge Winthrop to defer action on the Hearing Officer's Report and Recommendation with respect to Lydia Elias until January 8th. Motion carried. **BCCR-06-151.**

3-B: Review of pending requests for continuing education credit approval.

Kandace French presented the following pending requests for continuing education credit for the Board's approval. Staff is recommending one hour credit for each request.

3-C: Discussion and possible action regarding the Hearing Officer's Report and Recommendation with respect to Denise Style.

After discussions and advice from legal counsel, it is recommended the Board defer action until the February 12th meeting to allow legal counsel and Staff to draft an Order regarding the Hearing Officer's report.

Further **motion** was made by Jennifer Stadler and seconded by Judge Winthrop to amend the first motion to grant renewal certification for certificate holders 302-354. Motion carried. **BCCR-60-168.**

Motion was made by Jean Lea and seconded by Judge Winthrop to grant renewal certification for certificate holders 355-394. Jennifer Stadler and James Bouley recused. Motion carried. **BCCR-60-169.**

Motion was made by Jennifer Stadler and seconded by Judge Winthrop to grant renewal certification for certificate holders 395-439. Motion carried. **BCCR-60-170.**

The Board was informed Maureen Choate did not disclose on her application that she was convicted on 5/25/06 of extreme DUI. Staff has reviewed the renewal application and it appears she was not required to disclose this on the background information section.

Kimberly Siddall recommended the Board grant renewal certification.

Motion was made by Jean Lea and seconded by Patricia Seguin that renewal certificate be granted to Maureen Choate. Motion carried. **BCCR-60-171.**
