8 This matter came before the Disciplinary Commission of the Supreme Court of  
 9 Arizona on December 11, 2004, pursuant to Rule 58(e), Ariz. R. S. Ct., for consideration of  
 10 the Hearing Officer's Report filed October 4, 2004 recommending acceptance of the Tender  
 11 of Admissions and Agreement for Discipline by Consent (Agreement) and Joint  
 12 Memorandum in Support of Agreement for Discipline by Consent (Joint Memorandum)  
 13 providing for a censure, two years of probation effective the date of the final judgment and  
 14 order with the State Bar's Ethics Enhancement Program (EEP) and costs of these  
 15 disciplinary proceedings.
