Staff recommended the Board deny the request to withdraw the renewal application and deny renewal certification pursuant to ACJA § 7-201 (E)(2)(c)(2)(b)(vi) for having a suspension of a professional certificate and ACJA § 7-201 (E)(2)(c)(2)(b)(vii) for having disciplinary action of a professional certificate wherein the underlying conduct is relevant to the certification and ACJA § 7-201 (E)(2)(c)(2)(b)(xii) for violation of any order of a court, judicial officer, administration tribunal, or the board. It is further recommended the Board direct staff to contact each Probate Administrator and Clerk of Court as to the present

status of Ms. Bow's certification.
